

Local Government Pension Scheme Employer Estimate Request Form

Buckinghamshire Pension Fund

This form should be used by employers requesting an estimate of pension benefits and any applicable pension strain costs. Before completing this form, please note the following:

- Employers are entitled to two free estimates per scheme member in any rolling 12-month period. Any additional estimates can be provided at a cost of £15.00 plus VAT.
- Incomplete or inaccurately completed forms will be returned and the request will not be processed.
- This form is for an estimate only. It does not provide notice of an actual retirement. Actual retirements will only be processed when all applicable paperwork is received.
- In cases where a member has pre 1 April 2014 service, and a pension strain is payable, we may request additional final pay calculations for members who have had a drop-in pay.
- Employers are required to have discretionary policies for employer consent and flexible retirement. We are unable to supply these types of estimates if the employer does not have one in place.
